This cookie policy (“**Cookie Policy**”) describes how and why Two Sigma Investor Solutions, LP (“**TSIS**”, “**we**”, “**us**” or “**our**”) uses cookies (and other similar technologies) on <https://venn.twosigma.com> (our “**Site**”) and via our platform (“**Platform**”), their purposes, and how you can control them.

What are cookies?

A cookie is a small text file that a website saves on your browser, computer, or mobile device. It enables the website to remember your actions and preferences (such as login, language, font size and other display preferences) over a period of time, so you don’t have to re-enter this information whenever you come back to the website or browse from one page to another.

What are cookies used for?

We use cookies on our Site and Platform to make them work properly as well as to personalize your experience on our Site and/or Platform and to make your future activities and experience on our Site and/or Platform more efficient. We also use cookies to track, compile and analyze usage, navigational and other statistical information that allows us to understand how people use our Site and Platform, to engage in advertising and to help us improve the structure and content of our Site and Platform.

What other tracking technologies do we use?

When you visit the Site and/or Platform, we may also use other technologies such as pixel tags, browser analysis tools, server logs, web beacons, and other tracking technologies for similar purposes as described in this Cookie Policy and we may include them on our Site or Platform, in marketing email messages or our newsletter and affiliated websites to determine whether messages have been opened and whether links have been clicked on. The information provided below about cookies also applies to these technologies.

What types of cookies do we use?

Our Site and Platform may use the following types of cookies:

- **Strictly Necessary Cookies.** Strictly necessary cookies are necessary for the operation of our Site and/or Platform and cannot be switched off. Certain required cookies are set by our third-party vendors and cannot be modified by us.
- **Analytical or Performance Cookies.** Analytical or performance cookies allow us to recognize and count the number of visitors and to see how visitors navigate our Site and/or Platform when they are using it. This helps us to conduct analytics and improve the way our Site and/or Platform works.
- **Functional Cookies.** Functional cookies help us enhance functions, performance, and services on the Site and/or Platform. Functional cookies may be used to recognize you when you return to our website. They may enable us to engage in activities such as personalizing our content to you and remember your preferences.
- **Advertising Cookies.** We may also use advertising cookies which may track activity across websites in order to understand a viewer’s interests and direct them to specific Venn by Two Sigma marketing content. Such cookies may record your visit to our Site and/or Platform, the pages you have visited and the links you have followed and enable us to use this information to make our Site and/or Platform and the advertising we, or third-parties, display to you more relevant to your perceived interests.

Some of the cookies and tracking technologies we use, referred to as session cookies, are temporary and remain on your device until you leave our Site and/or Platform. Other cookies and tracking technologies are persistent and remain on your device for longer, or until you manually delete them. For how long the cookie remains on your device will depend on the duration or “lifetime” of the specific cookie and your browser settings.
